



# Active Membership Application

The Caribbean Cable and Telecommunications Association is a non-profit trade association for the cable television and telecommunications industry in the Caribbean. The objectives of the Association are to foster and promote the development of cable television service; promote cooperation and understanding among its members; encourage and promote high standards of service and conduct which will be for the best interests of the public and the cable television industry; protect its members in every lawful manner from unjust attacks and exactions and advance their mutual interests; disseminate information and broaden the public understanding of the cable television and telecommunications industry's role in the community; and carry on any operation or activity in connection with the foregoing objectives.

### APPLICATION FOR ACTIVE OR PARTICIPATING MEMBERSHIP

An Active Member shall be a cable television and/or telecommunications system serving a community or area in the Caribbean. To qualify as an Active Member, an individual, firm, group or corporation must be actively engaged in the business of providing television signals and/or communication services to subscribers utilizing connecting wire, cable or relay facilities and associated equipment.

A Participating Member shall be any individual, firm, group or corporation which has a valid local franchise to build and operate a cable television or telecommunications system in the Caribbean, but which has not yet begun serving subscribers.

The undersigned hereby applies for membership in the Caribbean Cable and Telecommunications Association, a trade association organized under the laws of the Territory of the Virgin Islands as a non-profit corporation. The applicant certifies to being a duly licensed or franchised owner/operator engaged in the business of bringing cable television and/or telecommunications services to the public in the Caribbean region by means of cable television systems utilizing connecting wire, cable or relay facilities and associated equipment, and non-standard television systems, run in whole or in part along public rights-of-way for the distribution of television, information or intelligence by electronic means to subscribing members of the public. Any applicant further agrees to cause all such cable television or telecommunications systems of identical or similar ownership or control in the Caribbean to simultaneously subscribe to membership with full voting privileges in the Association; that the information submitted herewith is true and complete; and does now hereby agree to subscribe to and abide by the Bylaws of the Association as now in force or shall be duly amended hereafter. CCTA reserves the right to request additional information.

*Membership shall become effective upon approval by the Board of Directors.*
